## Use instructions

### Dosage

TASKI Jontec 300 is available in various pack sizes and is either dosed manually (standard concentrate) or through one of our dosing and dispensing systems (EXACT, J-Flex®, QuattroSelect®, IntelliDose™). For detailed information regarding the specific dosing equipment, please refer to the Technical Data table. Proper dosage saves costs and minimises environmental impact.

### Application

1. **Wet mopping:** Dose the product into a bucket filled with water, apply the solution and remove the soiled solution.
2. **Spray cleaning:** Dose the product into a labeled trigger spray filled with water, apply to a small area and work over area with a red pad, fitted under a single disc machine.
3. **Scrubber drier:** Dose the product into the full water tank, apply the solution, scrub and remove the soiled solution. For heavy soils allow contact time.
