Dilute 1:50 parts hot water (100 ml per 5 L / 3 x  per 5 L). Mop or wipe surface.

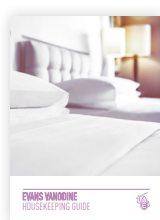
After use we recommend cloths or mops are rinsed in a fresh solution of PROTECT™ and allowed to air dry.
